- d. Announcement of results: Ammar Malebari, Yassir Mahmoud and Omar Mancini were elected to fill the vacancies for the remainder of the 2011-12 term.

Closing Prayer: Mohamad Al-Saqer offered the closing prayer.

Motion to Adjourn: A motion was made and seconded to adjourn (Mohamad Al-Saqer/Samil Sermet). Passed - Unanimous. The meeting adjourned at 2: 15 pm.
